





This registration letter is issued under the following conditions. It reserves the right to cancel the above mentioned (registration) permission, if it violates any of these conditions.

1. This registration letter is subjected to the provisions of Karnataka Educational Institutions (Regulation, Classification of Private Disciplinary Institutions) Rule-1997 , rule 3(5) (D)
2. As per Karnataka Education Act (Classification, Regulation and prescription of syllabus...etc ) Regulations 1995, Rule 4, 5, 6 and 8; as a safety measure, the school building should have a high quality roof and should have good ventilation and lighting. School should Provide separate toilets for boys and girls. Should provide drinking water. School should ensure that compounds must be constructed for safety of school premises, and measures should be taken to prevent fire hazards
3. In any case, the institution cannot open more sections without the government's prior approval.
4. The school shall be opened only in the medium sanctioned and in the same place as per Karnataka Education Act-41 (5) and shall not be allowed to be change the location for any reason.
5. No other governing body is allowed to run the school, other than the governing body which has obtained permission to open the school. The governing body which is permitted to open the school shall not be allowed to change the place and name for any reason and is not permitted to transfer the same..
6. The Educational institution shall abide by all the governmental orders in force and frequent issuance of rules and the regulations. The education institution should follow Karnataka Education Bill 1983 (Karnataka Act No. 1:95) and abide by the provisions of the Act and the regulations thereunder.
7. This primary school registration is permanently unaided as per Government Notification No. ED 175 PMC /95 Dated 7-9-98 and 29-12-98. (permanently without aid)
8. The education institution shall abide by the Karnataka Private Educational Institutions (Discipline and Regulation) Rules 1999.
9. The Karnataka Educational Institutions (Classification, Regulation and prescribing of curriculum , etc.) Regulations 1995, the institution must use the textbooks fixed by the Department and the Government and ensure that curriculum should not be burden to the students.



10. Term fees, tuition and special development fees shall be charged only as per Karnataka Educational Institutions (Classification, Regulation and Curriculum fixation) rule 1995 Dated: 12-10-96. As per the rule 10(04), the institution should display the details of fee to be collected by the students / parents on notice board and should submit a copy of it to the concerned BEO/DDPI.
11. Karnataka Educational Institutions shall abide by (Regulation of Certain Fees and Donations) Govt. Notification No: ED.39, vidda 99, dated: 14-03-2000; Rule-1999 and shall not collect any other fee.
12. To get the recognition renewal within two months; as per the Karnataka Education act 1983 ( Act 1 of 1995) section 36 to 39 and ED 131, viddha-98, Bangalore dates : 14-11-99) and the school has to submit an application the concerned authority vide Govt. notification No. Ed 137, vidda98, Bangalore Dated 19-05-99. To start the school fixed security deposit has to deposited in the joint account of DDPI and secretary of the governing council of the institution.
13. As per Govt order No. ED 28 PGC-94 dated: 29-04-2000; language policy should be followed and school has to run in kannada medium from 1-5<sup>th</sup> standard.
14. As per Govt notification no. ED 52, 99, Dated: 2-2-2000 annexure -5 student teacher ratio has to be maintained for all the classes for which permission is taken.
15. As per the department qualified and trained teachers must be recruited.
16. As per Karnataka Education Bill, the school should provide the necessary furniture, classrooms, libraries, etc. in one year, playground and school buildings within three years.
17. School working hours and working days shall be observed as per departmental rules.
18. The office should be notified of the school's commencement and student enrolment within two months of the school's enrollment or academic year. If the school does not open and does not meet any conditions, this order is automatically gets cancelled.
19. 7th grade should be started on the basis of natural growth.
20. If there are already Kannada medium 1-7<sup>th</sup> classes, care must be taken so that there shouldn't be any disturbance to Kannada Medium Classes by the permission of English Medium Higher primary classes.
21. Comply with the instructions of Government Circular No. ED-27 ESP -03 Dated:13-02-2003 and open the service book of the staff appointed in the school, and service details must be recorded as per the norms.
22. Teachers must be assigned to Census work.
23. This registration will gets cancelled if any documents are found to be false in the proposal submitted.
24. Any book in English medium should not be used in addition to Kannada / Mother tongue (as language book) in Class 1-5.
25. This registration will gets cancelled if any documents are found to be false in the proposal submitted.
26. School is conditioned not to be relocated and handed over for a period of 5 years after approval.




As per the Right to Education Act 2012, Children's free and compulsory elementary education regulations are implemented. : As per the 2-F rule of 2012, Karnataka Free and Compulsory Education Act for Children; the primary education cycle is to be implemented in the school education system from 1st to 8th grade has been instructed to follow the modified rules. From 2013-14; primary education level is fixed as 1-8th grade and ordered the same in Ref (2) dated 18-02-2013. And this order has been modified and circular has been given vide ref no. (2) dated: 24-04-2013. As per the circular; upgradation to 8<sup>th</sup> grade has been held up from 2013-14 for the govt. and unaided institutions which are running 1-7<sup>th</sup> classes. However, DDPI visits such institutions which wish to run upgraded 8<sup>th</sup> standard to ensure the basic facilities and trained teachers details. Spot inspection report will be collected & verified from BEO in this regard.

As per the ref (3), after the verification of proposal submitted by the management and according to the spot inspection done by BEO; with conditions to provide basic facilities and recruitment of trained teaching staff for higher primary school, with own responsibility of the school management, permission has been given to **Sri Taralabalu Jagadguru Higher Primary School, Sirigere, Chitradurga Taluk** running under **Sri Taralabalu Jagadguru Education Society ® Sirigere** to run 8<sup>th</sup> Standard in English medium from 2020-21 with RTE norms.

Conditions:

1. Within two months of the recognition order, the institution should submit proposal for first recognition for the grade permitted.
2. The Governing Council must follow all the conditions set as per New Schools Registration Act-1995
3. The school should provide, Land, Building, furnitures, teaching materials, staff and financial facilities.
4. The institution is not supposed to start additional sections without the prior permission from the

5. The school shall be opened only in the medium sanctioned and in the same place, and shall not be allowed to change the location for any reason.
6. The governing council shall run the school in the same name for which permission is taken and should run the school in same name in the same location, there will be no provision to change the location and transfer of institution without the prior permission from the govt..
7. As per Govt notification No. ED-175: PMC95 and ED:175 PMC-97 dated 29-12-98 all the schools running under this institution are treated as permanently without aid.
8. Student teacher ratio has to be maintained for all the classes for which permission is taken.
9. Under RTE regulations and department norms; the institution should recruit qualified and trained teachers only.
10. The office should be notified of the school's commencement and student enrolment within a month of commencement of the academic year to the BEO. If the school does not open and does not meet any conditions, this order gets cancelled.
11. Comply with the instructions of Government Circular No. ED-113 VVD: 2005 Dated 02-11-2006 open the service book of the staff appointed in the school, and service details must be recorded, staff must be paid minimum salary as per norms through bank accounts .
12. The school shall start functioning only after providing basic facilities.
13. The governing council must abide by all the regulations of Children Education Act-2009 to carry admission process, recruitment of teaching staff and to provide basic facilities.




